Additional reviews of re-submitted or revised plans and /or additional site inspections shall be calculated at the rate of \$75.00 an hour, with a minimum fee of \$75.00.

* Residential and Commercial Development Reviews – Fees will also include the amount of fire hydrants located within the project. Fees will be \$200.00 per fire hydrant.
